**Leadline division**

Open to riders 8 years and under who are not ready to ride in a group off the lead line. Not NEHC or MHC rated.

**X-rail division**

Open to riders or horses in their first years of showing. Simple changes count as flying changes. Fences 18", no cross entry in to any other division at this show. Not NEHC or MHC rated.

**Beginner division**

Open to walk trot riders of all ages. No cross entry into other divisions at this show. Riders will walk and trot only. Not NEHC or MHC rated.

## Show Rules

- Trophy and six ribbons per class.
- All classes offered are covered by the rules of NEHC and MHC
- Show ring and Warm up arena are both indoors, 80' x 200' with sand footing
- PROTECTIVE HEAD GEAR:

Protective Headgear which meets or exceeds ASTM/SEI standards for equestrian use and carries an SEI tag must be worn by all riders at all times while mounted on a horse or pony. Head gear must be properly fitted with the harness secured at all times. (See Rule GR 801)

- VETERINARIAN :

I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death ("Harm").  
 I AGREE to release the Competition from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of the Competition.  
 I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Competition.  
 I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the Competition I AGREE to waive the right to the use of my photos or my image at the competition.  
 If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to all of the above provisions and AGREE to assume all of the obligations of this Release on the child's behalf.
